Equipment and systems covered by this Certificate are as follows:

Flameproof signal towers can be operated in hazardous areas of zone 1 or 2 (gas group IIA, IIB, IIC, temperature class T5 and T6) or in zone 21 or 22, dust group IIIC, T120 °C. The flameproof LED-Matrix-Displays can be operated in hazardous areas of zone 1 or 2 (gas group IIA, IIB, temperature class T4) or in zone 21 or 22, dust group IIIC, T120 °C. Both versions consist of a flameproof and dustproof enclosure „Ex-d“ in which signal modules are installed.
